

# HARWARD

## PERFORMANCE LIVESTOCK

This contract certifies \_\_\_\_\_, hereafter referred to as Mare Owner, has engaged in one service to **One Time Playmate**, AQHA #5746992 owned by Kolby Harward, for the mare \_\_\_\_\_, Breed \_\_\_\_\_, Registration # \_\_\_\_\_, for the 2025 breeding season (*the breeding season shall begin February 3<sup>rd</sup> and close June 30<sup>th</sup> of the year covered by this contract*) at a fee of \$1,000.00 (USD). Kolby Harward, the agent for the above named stallion, will herein be referred to as Breeder.

1. A non-refundable booking fee of \$500 is payable with this contract and the entire balance plus all unpaid expenses (including shipping charges) will be payable prior to shipment of semen/ breeding of mare.
2. The Mare Owner shall agree that the mare offered for breeding shall be in sound breeding condition and free from infection or disease. Any mare certified by the attending veterinarian not to be, in their opinion, in sound breeding condition, shall not be bred. It is the Mare Owner's responsibility to verify health and breeding soundness of the mare. It is further agreed that should the above named mare die prior to foaling, the Mare Owner may substitute another mare, to be use in the following season only, if it is agreed to by both the Mare Owner and Breeder. Pregnancy exam must be completed within 30 days of insemination. Any fees associated with the pregnancy exam are the responsibility of the mare owner.

3. The Breeder agrees to diligently try and settle the above named mare, if however, the mare does not settle, the Breeder shall be held harmless. Mare Owner agrees to assume responsibility for all facets of breeding the mare and agrees to use all semen provided by this agreement solely to breed the Mare named above. Any attempt to use any portion of any semen shipped to Mare Owner to breed any other mare shall automatically terminate all obligations of this agreement and result in forfeiture of all breeding fees, shipping fees, booking fees and the right to a breeder's certificate.
4. Live Foal Guarantee: Live Foal means the foal shall stand and nurse. It is understood that if the mare proves barren, aborts her foal or if the foal is stillborn, a rebreed will be guaranteed the following year only, providing proper notification is given. Proper notification shall be defined as follows: Written certification by a licensed veterinarian within seven days that the mare has slipped or produced a non-viable foal. Mare Owner certifies that such abortion or death did not result from any act or omission of the Mare Owner. The Re-Breed Fee of **\$350** is due prior to rebreeding for Live Foal Guarantee or if said mare did not get in foal from previous year's breeding efforts. Rebreeds are only available the year immediately following the initial contract breeding season and do not cover breedings purchased through a stallion service auction or otherwise owner discounted breeding. Mare owner will be responsible for any additional fees accrued by South Valley Equine Reproductive Center.
5. A Breeders Certificate will only be issued to Mare Owner upon request and upon notification of birth of the foal. Mare Owner shall contact the Breeder no later than August 1 of foaling year. Breeding certificates will not be issued for the foal until all expenses have been paid in full.
6. Multiple Foals: The payments provided in paragraph 1 are for one foal for this breeding season from this Mare. Should more than one

embryo or foal result from a breeding, Mare Owner shall pay an additional Breeding Fee within 60 days of confirmed foal for each additional embryo or foal. No breeding certificate for any foal will be issued without additional payment.

7. If mare is to be live covered on the property mare owner will be responsible for a \$15 per day charge for every day the mare is kept on site. The additional boarding fee is the responsibility of the mare owner. The mare owner also fully acknowledges the risks associated with live cover breeding and takes full responsibility for the mare. Any risk, injury or illness that may be associated with live cover breeding to mare is the responsibility of the mare owner. The mare owner will not hold Kolby Harward or Harward Performance Livestock liable for any loss, injury or illness that the mare may inquire while on the property. Mare owner live cover breeds at their own risk.

South Valley Equine Reproduction Center fees (per shipment):

Please contact South Valley Equine for their current pricing for collection and shipping of semen. Mare owner is responsible for any fees accrued at South Valley Equine.

Mare owner is responsible for scheduling and coordinating breed dates with South Valley Equine

Stallion collection/shipping days are Monday, Wednesday and Friday. Orders for shipments are filled on a first come, first serve basis. Orders must be placed by 4pm MST the day prior to the necessary collection day. Orders can be confirmed and/or cancelled by 9:00 am MST day of collection. The Mare Owner is responsible for all charges acquired by

South Valley Equine Reproduction Center. South Valley fees are in addition to the breed fee. If cancellations are received after shipment has already been sent. Shipment orders cannot be guaranteed if they are placed via email, you must call to confirm. Every attempt will be taken to deliver cooled semen to Mare Owner in good condition, however once the shipment leaves South Valley Equine, Harward Performance Livestock cannot be held responsible for delayed arrival or condition of semen upon arrival to Mare Owner.
